Introduction

Onboarding Process Steps

1. Access the Registration Page

- Navigate to the [Antwort.lu login page](#).
- Click on the "Sign Up" option to initiate the registration process.

2. Complete the Registration Form

- **Country of Residency:** Select your country from the dropdown menu.
- **Investor Classification:**
 - Confirm whether you are a **well-informed investor** or a **professional investor** by reading the provided definitions and checking the corresponding boxes.
- **Personal Information:**
 - **First Name** and **Last Name:** Enter your legal names.
 - **Role:** Indicate your status (e.g., Individual Investor, Family Office, Private Banker, etc.).
- **Contact Details:**
 - **Email:** Provide a valid email address for communication.
 - **Phone:** Enter your contact number.
- **Account Security:**
 - **Password:** Create a strong password and confirm it in the designated field.
- **Agreements:**
 - Review and accept the Data Protection Notice and Terms of Service by checking the required boxes.
 - Read and accept the Non-disclosure Agreement.
- **Verification:**
 - Complete the CAPTCHA to confirm you are not a robot.

3. Submit Your Application

- After ensuring all information is accurate and all required fields are completed, submit the registration form.
- You will receive a confirmation email once your account has been validated and activated.

- Upon account activation, log in to your Antwort.lu account.
- Browse and review the available fund teasers and investment opportunities open for subscription.

5. Access the "Invest Now" Button

- Once you have chosen the fund you wish to invest in, click the **"Invest Now"** button to begin the onboarding process.
- Before proceeding, you must confirm:
 - Whether you are a resident of one of the countries listed in the pop-up message.
 - If you are not a resident, you must acknowledge that you have not been contacted or solicited by Antwort Capital regarding any investment in this Feeder Fund.


6. Onboarding Process

- Select the **type of investment** you will be making:
 - As an **individual investor** (natural person)
 - As a **representative of a company**
- Complete the required fields with accurate information. **For company onboarding**, please ensure you specify the **Beneficial Owner(s)/Controlling Person(s), Controlling Person(s) by other means, and Senior Managing Official**, if applicable. These individuals will receive a form to complete and digitally sign as part of the process.
- Please note that you will need to upload certain **supporting documents** depending on your type of investment in the final step of the onboarding process.
- **Important:** It is mandatory to **download and review the informational documents** provided in the first step of onboarding **before subscribing to the fund**.
- Click "**Submit**"






9. Review and Approval

- After completing the onboarding process, the **Antwort Investor Relations (IR) team** will review your documents and submit them to **Adepa**, our Transfer Agent, for **AML and KYC checks** to assess your eligibility as an investor in the fund.
- During Adepa's review, they may request **additional information or documentation** they deem necessary. If this occurs, a member of the Antwort team will contact you directly to guide you through the next steps.
- Once Adepa approves your application, a member of the Antwort team will notify you and send you the **Subscription Agreement** via email for your signature.
- The **Subscription Agreement signature** is the **final step** in completing your investment process.

Once the Subscription Agreement is signed, your investment will be finalized, and you will officially be onboarded into the fund.
